

Sehr geehrter Herr v. Bertrab,

die Erfahrungenbei der Bearbeitung der Spende des Irischen Roten Kreuzes sind nicht zuletzt Anlass zu grundsätzlichen Überlegungen gewesen, die wir uns dieser Tage über die Frage der Spendenverteilung gemacht haben, und über deren Ergebnis Sie durch ein besonderes Schmiben hören werden.

Zu der Verteilung der Irischen Spende wird, wie wir neulich schon in München besprachen, auf eine Beteiligung der französisch en Zone verzichtet.

Nachdem Irland nachträglich noch zwei weitere Kisten avisiert hat, haben wir von diesen je eine an die Landesverbände Niedersachsen und Schleswig-Holstein gegeben, da ja, wie Sie selbst in Ihrem Schreiben vom 9.9. feststellten, die Bevorzugung von Berlin bei der ersten Verteilung ganz zu Lesten der britischen Zone ging. Insgesamt sind also aus dieser Spende 18 Kisten verteilt worden und zwar, wie folgt:

6 an Landesverband Berlin

5 " das Bayerische Rote Kreuz, München

4 " Landesverband Niedersachsen, Hannover

" Landssverband Schleswig-Holstein

Die Gewichtsangaben lassen wir Ihnen zugehen, sobald wir die Ziffern für die letzten beiden Kisten haben, die uns noch fehlen.

MEMORANDUM

The Alleviation of Distress in Germany and Austria

During the war, owing to difficulties of transport and of a military nature, the Government was unable to make grants in kind for the alleviation of distress abroad. A money grant of £100,000 was, however, made to the Irish Red Cross Society in the financial year 1943/44 for war relief and famine relief in India and Europe and a further £100,000 was voted during the financial year 1944/45 for presentation to His Holiness the Pope to be used for relief schemes sponsored by the Vatican.

With the end of hostilities it became possible to send to Europe commodities which were sorely needed in the various countries ravaged by the war. In July 1945 the sum of £3 million was voted by the Dáil for foodstuffs, blankets and clothing. One-fifth of these supplies was allocated to the Joint Relief Commission of the International Red Cross for distribution in the following countries: Albania, Austria, Bulgaria, Czechoslovakia (including German Civilian Internees in Slovakia), Germany, Hungary, Northern Italy, Poland, Rumania and Yugoslavia. The following Table shows the quantity and value of relief goods shipped to the International Red Cross up to the 31st March, 1946, i.e. the end of the financial year 1945/46:-

It is interesting to note that Irish relief supplies were distributed in Berlin and the Russian Zone of Germany by virtue of a special agreement between the Soviet Commander and a delegate of the International Red Cross.

This agreement leid down that no account should be taken in the distribution of political allegiance or religious profession and that only these in need should benefit. Further, Irish supplies were the first foreign relief supplies to be distributed in the Russian Zone and given publicity in the press.

Under this Vote of £3 million made in July, 1945 a contribution of £38,000 was made to the Irish Red Cross Society towards the expenditure by the Society on the purchase and shipment of relief supplies for Europe generally.

In July, 1946 a further £3 million was voted by the Dail for the relief of distress in Europe. The following supplies were made available to Austria under the 1946 programme:

Approximately 1,250,000 lbs. of frozen meat, being the equivalent of 2,000 head of cattle, were shipped to Austria under the scheme and in addition 100 tons of bacon were given to Austria in response to an appeal in May 1946 from the UNRRA/EECE Standing Committee on Starvation Conditions in Europe. The following supplies were made available to Germany:-

In addition 230 head of cattle were shipped to the U.S. Zone and 1,250,000 lbs. frozen meat to the British Zone.

Under the 1946 Gift, payments amounting to £91,644. 5. 7. were made to the Italian Government and to the Joint Relief Commission and a payment of £5,418,18.5 was made to the Irish Red Cross Society in respect of the purchase and shipment of relief supplies generally. Up to the 31st December, 1946 the distribution of Irish relief to Germany and Austria had been handled by the Joint Relief Commission of the International Red Cross Society. After the 31st December, 1946 distribution of the still available Irish supplies was handed over to the International Centre for Relief to Civilian Populations, Geneva. In October, 1947 the remainder of the supplies in possession of the International Centre was handed over to the National Catholic Welfare Centre. In the financial year 1947/48 payments amounting to £45,802.18.5. were made to or on behalf of the Joint Relief Commission and to the International Centre for transport charges and other expenses incurred by them on the distribution of relief supplies. A sum of £3,312.19.1. was given to the Irish Red Cross in recoupment of expenditure on the purchase and shipment of supplies, and a grant of £9,750 was made to the intergovernmental committee on refugees. financial year 1948/49 a sum of £9,123.12.5 was made to the Joint Relief Commission of the International Red Cross for transport charges and other expenses incurred by them in connection with the distribution of supplies sent to Europe in previous years. A sum of £2,740.15.1. was paid to the Irish Red Cross Society in recoupment of expenditure on the purchase and shipment of supplies.

On the 14th December, 1950 in response to a request from the National Catholic Welfare Conference, Paris, a supply of canned meat to a total cost of £25,000 was made available for the relief of distress. Five tons of

stewed steak were supplied to Berlin; 2,083 cartons (each containing 48 x 1 lb. cans) were supplied for relief in Germany generally and 938 cartons (each containing 48 x 1 lb. cans) for relief purposes in Austria. The balance of the meat was sent to France and Italy.
